ART. 1 - DATE/SCHEDULE OF THE SHOW

The BMT, Mediterranean Tourism Exchange, organized by Progetta srl, via Vannella Gaetani 27 - 80121 Naples, will be held in Naples from 13 to 15 March 2025 at the Mostra d'Oltremare Exhibition Complex. The stands must be ready and open to visitors no later than 09:30 on 13/03/25 and cannot be emptied before 18:00 on 15/03/25.

ART. 2 - REGISTRATION

2.1 Participating Subjects

Exhibitors' registration requests must be sent to Progetta s.r.l. by means of the "exhibition space reservation" form and will be accepted until the available spaces within the exhibition area are exhausted. The Organization reserves the right not to accept, at its sole discretion, requests deemed not in line with the purposes and spirit of the event. The application form must be completed with the payment of the deposit. By signing the application form, the Exhibitor undertakes to participate in the event in the stand that will be assigned to him and to accept without reservation the General Regulations of the Mostra d'Oltremare, the Regulations of the event, the rules and technical provisions and all those supplementary prescriptions that will be adopted at any time by the Organizing Secretariat in the interest of the event.

2.2 Responsibility of the Organization

The Organization disclaims any liability that may arise, to any person, from facts attributable to participants in the Event also as regards compliance with the provisions governing the performance of the Event itself.

ART. 3 - PAYMENTS

The advance is payable on the act of reservation. **It is required to pay the balance of the participation fee and ancillary services within 40 days before the start date of the event**, in the absence of this payment, the set-up of the stand will not be allowed. The Organization reserves to itself the right to cancel any possible non rectified enrollment through payment on the term provided of fees and accessory services.

ART. 4 - POSSIBLE CANCELLATION

The exhibitor may cancel the reserved spaces by giving formal notice 90 days before the event by registered letter with return receipt upon reimbursement to the organizer of the expenses incurred which, on a flat-rate basis, are determined to the extent of 25% of the amount paid. Beyond this term, the Progetta srl acquires the right to collect the sums paid for any reason by the renouncing company and to dispose of the available areas in its opinion. This without prejudice to any legal action for the recovery of the entire amount of the parking fee and any damage. In the event of any cancellation up to 110 days before the event, it is possible to proceed with the cancellation without applying any penalty.

ART. 5 - STAND ASSIGNMENT

The location of the stands will be made by the Organizers who, as far as possible, will take into account the requests and needs of the Exhibitors. The Organizers reserve the right to change the assignment of the stands if this is necessary for technical, sectoral or other organizational reasons.

ART. 6 - CATALOG DATA

The data shown in the catalog will be carefully transcribed from the appropriate form on card 1. Any errors or omissions will not, however, give the right to any type of refund or compensation.

ART. 7 - POSSIBLE CANCELLATION MANIFESTATION BY CAUSE OF FORCE MAJEURE

If due to force majeure or in any case for reasons not dependent on the Organizer and / or if the competent authorities do not allow the running of the Exhibition due to factors related to the health emergency, the exhibitor accepts that the amounts paid as a deposit and / or balance of the participation fee are set aside and used, under the same conditions, for participation in the next edition of the fair.

ARTICLE 8 - MATERIAL DISTRIBUTION AUDIOVISUAL ADVERTISING

The material of any kind, displayed or distributed, must be exclusively of a tourist nature. Any audiovisual advertising must not disturb the smooth running of the event and may be suspended at any time by decision of the Organizers. The Exhibitor bears all responsibility for what is transmitted, as well as the obligation to obtain authorizations and pay taxes and copyrights. Any type of sale to the public with immediate delivery is prohibited.

ART. 9 - RISK INSURANCE

The Organizers decline any responsibility for natural risks and force majeure. The Exhibitor is obliged to be insured against all risks including theft and fire or to declare not to exhibit material that requires insurance coverage. Insurance can be carried out by the Exhibitor at any Insurance Company. The exhibited material will be supervised only by the normal security services of the Mostra d'Oltremare as there is no specific surveillance, so during the setting up and dismantling phase we recommend special direct attention to valuable material such as monitors, DVDs, computers, furnishings special panels and the like.

ART. 10 - ASSEMBLY AND DISASSEMBLY

The customization of the pre-fitted stands must take place on 12 March 2025 from 11:00 to 18:00. The dismantling of pre-fitted stands is allowed from 18:00 and no later than 20:00 on 15/03/25. We inform you that the stands must be completely emptied by 20:00 on Saturday 15 March 2025 and not before 18:00. Material left in the stands after 20:00 on Saturday 15 March will be considered abandoned. Any exceptions to this provision must be authorized by the Organizer. Valuables can be deposited at the secretarial warehouse on 15/03/25, and must be collected on Monday morning 16/03/25 by 12:00. The dismantling of the stands set up on their own on a free surface must take place exclusively on Saturday 15 March from 18:00 to 20:00 and on Sunday 16 March from 08:00 to 19:00. After this deadline, the material not collected will be considered abandoned; the costs of disposal of materials abandoned after 16/03/25 will be charged.

ART. 11 - PREPARATION OF FREE SURFACE

Exhibitors who purchase the free space are required to submit the executive design and the render of the set-up they intend to prepare within 30 days before the start of the event. The set-up must comply with the layout of the event and approved by the technical office.

ART. 12 - RETURN OF SPACES

The stands must be returned in the condition in which they were taken over. Any restoration costs are borne by the Exhibitor, who is also responsible for observing the special rules for the use of structures and technical systems.

ART. 13 - POSSIBLE MODIFICATION OF THE REGULATION

The Organization reserves the right to modify these regulations in the event that, after the drafting of the same, there are facts or reasons that make any modification indispensable.

ART. 14 - OTHER INFORMATION

Without prejudice to all the rules and special provisions regarding meetings in public places, it is forbidden to light fires and introduce explosive material, detonating, foul-smelling or otherwise dangerous products and likely to cause damage and harassment. Any other information not foreseen by the regulation can be requested from the BMT secretariat. Any complaints of any kind must be sent to the same secretariat only in writing within 7 days from the end of the Exhibition.

ART. 15 - GENERAL REGULATION

For anything not provided for or specified in this regulation, the general rules and provisions of the General Regulations of the Mostra d'Oltremare S.p.A. apply.

ART. 16 - JURISDICTION

For any dispute, the Court of Naples will be exclusively competent.

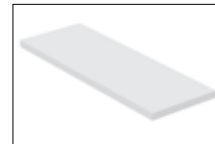

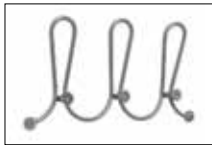
